# Part 2. Students, PhD students, Post graduate students Students

### Rights of the student

**Art. 109** (1) Besides the legal rights written in the Bulgarian Constitution, each student of the Academy has the right to:

- 1. Get education and specialization, accordingly to the Curricula and national requirements and conformity with current achievements in the concrete science area.
- 2. Study whole programs of the courses, included in the Curricula.
- 3. Choose elective and faculty courses.
- 4. Get help from professors and teachers to gain scientific knowledge.
- 5. Use all of the facilities of the Academy
- 6. Participate in Scientific researches conformity with his/her Scientific Preparation
- 7. Use the recreation, sport and tourism centers at the Academy conformity with the Regulation of NSA "Vassil Levski" and have medical treatment conformity with the Health Law.
- 8. To express his/her opinion about the quality of education conformity with the Academic procedure.
- 9. Chose and be chosen in the Managing body at the Academy and its structures conformity with the procedure and the cases written in the law.
- (2) The students has equal rights. Criteria for evaluating their work and encouraging them are the marks, the sport results, the public activity for general benefit of National Sports Academy "Vassil Levski", scientific contribution.
- (3) The student has the right to defend his/her rights conformity with the established legal procedure. It is not allowed to use sanctions against student who has used his right legally.

#### **Obligations of the students**

Art. 110. Every student of the Academy has the obligation to

- 1. Assist all classes ant to participate actively in them.
- 2. Prepare carefully and to pass all exams in the deadlines and to do the other obligations conformity with the Curricula.
- 3. Obey the established behavioral rules and the interior regulations of NSA "Vassil Levski"
- 4. Respect all teachers, administrative leaders, staff and other students.
- 5. Contribute with his/her activity and behavior for saving the reputation and rising the prestige and the scientific authority of the Academy
- 6. To obey the rules for academic ethic on the territory of the Academy
- 7. To obey other obligations, rules and internal deeds of the Academy

#### **Encouragement of the students**

- **Art. 111.** (1) For good results, achieved during the academy year, for scientific and sport activity and for good civil behavior each student of the Academy could be encouraged by
  - Public Praise
  - Money
  - Individual high valued gift
- (2) The mentioned encouragements in the previous paragraph are given to the student in assessment of the rector or the dean. They are bestowed on the student on official events.
- (3) Student, who has graduated with 6.00 (A+) receives as a present the decoration "Outstanding" of National Sports Academy "Vassil Levski"

#### **Punishments**

- Art. 112. (1) Student who kakvo zbreaks the law and the internal regulations of the Academy is disciplined no matter the other types of responsibility when they are created for the same act.
- (2) The Punishments of the studnets are:
  - 1. Remark
  - 2. Warning for dismissal from the Academy
  - 3. Dismissal from the Academy
- (3) The first and the second punishment from the previous paragraph are applied by the Rector or the Dean, but the third punishment is applied by the rector after suggestion of the dean. The punishment is applied with written order which is given directly to the student and when it is impossible to be given to the student it is sent by post to his address.
- (4) The punishment should be applied till 2 months after the infringement but not later than 1 year after the infringement.
- (5) The person who applies the punishment is obligated before this to listen to the student or to accept his/her written statement which he has to take in consideration. When the statement could not be listened or accepted and the cause for this is student's this regulation is not valid
- (6) Dismissed student could be rehabilitated of his/her will with order from the rector not earlier than 1 year and not later than 3 years later the date of his/her dismissal under the condition in the order is not indicated something else.
